Kishan Samarasinghe

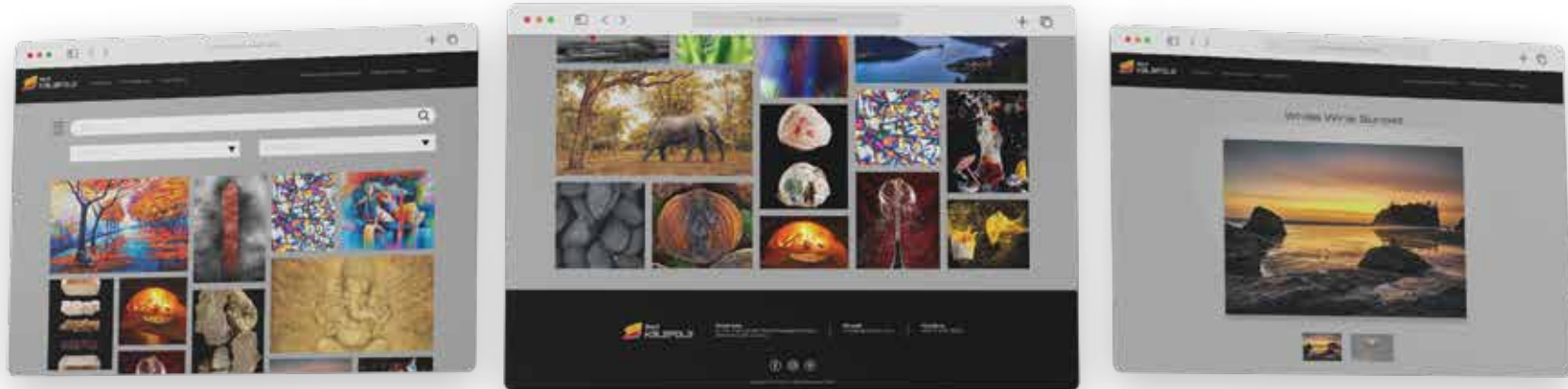

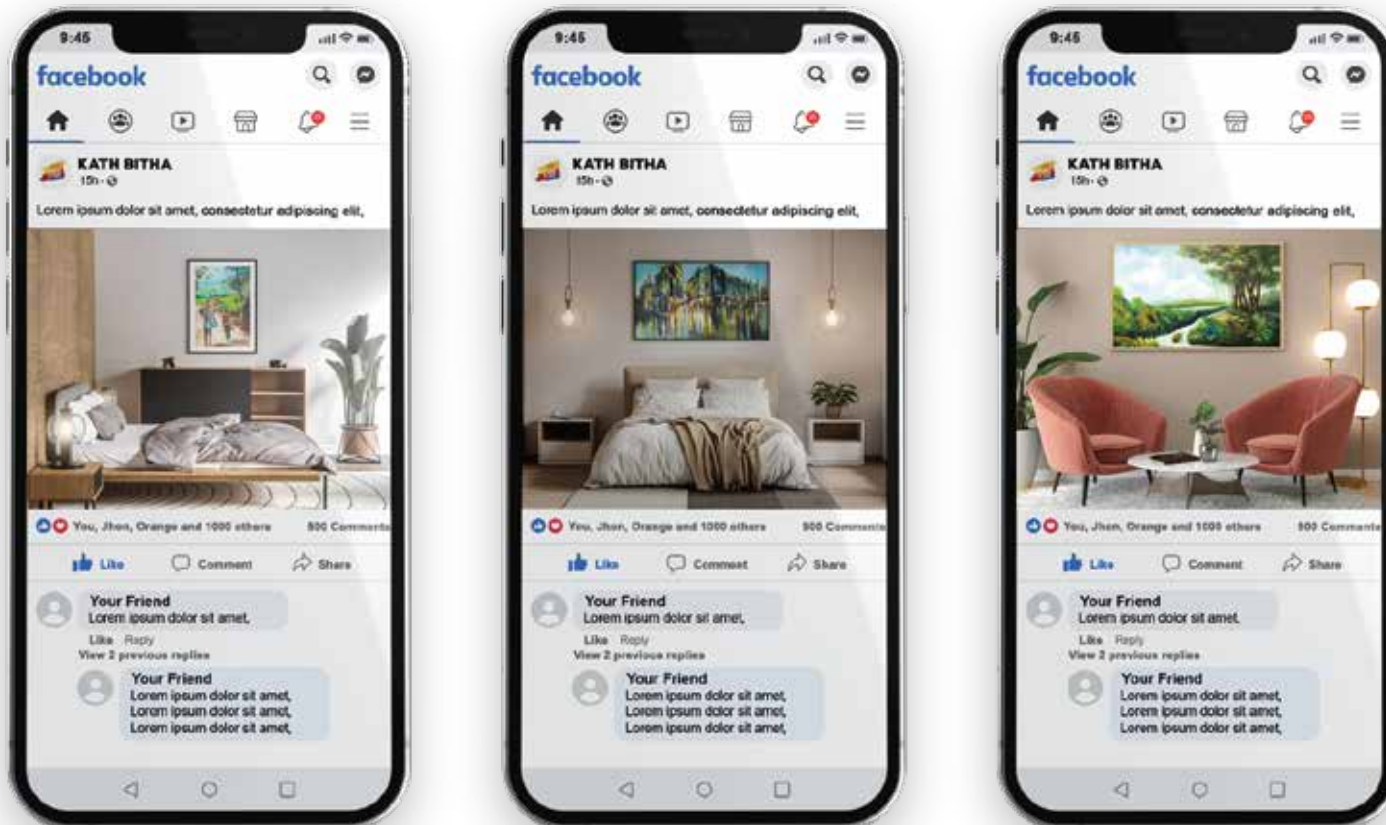
